#### Information on post-graduate funding (application procedure)

Based on the Post-Graduate Funding Act – GradFG of the state of Saxony-Anhalt as published in the announcement dated 30.07.2001 (Law & Ordinance Gazette LSA No. 35/2001, p. 318), amended on 11.03.2011 (Law & Ordinance Gazette LSA p. 488), and most recently amended on 10.12.2015 (Law & Ordinance Gazette LSA 613) and the implementing measure, Post-Graduate Funding Directive – GradFVO, dated 02.06.1992 (Law & Ordinance Gazette LSA p. 402), amended on 01.08.2001 (Law & Ordinance Gazette LSA no. 35/2001, p. 322), amended on 09.07.2011 (Law & Ordinance Gazette LSA p. 384) and most recently amended on 04.02.2016 (Law & Ordinance Gazette LSA p. 52), every year, post-graduate bursaries are awarded at Otto von Guericke University Magdeburg.

#### An application may only be made after successfully obtaining a university degree.

The originals of the following application documents must be submitted to the **dean's office in** the relevant faculty:

- 1. Application for post-graduate funding,
- 2. Curriculum vitae in tabular form;
- 3. Presentation of previous academic achievements and explanations regarding the preparatory work carried out for the research proposal,\*
- 4. Work program (content description of the proposal and methodology) <u>and</u> work schedule (detailed timetable),\*
- 5. Statement of willingness from a professor or a university or private lecturer at Otto von Guericke University Magdeburg to supervise your project,
- 6. Statement from the supervisor of the dissertation and an additional professor or univer-sity lecturer concerning the applicant's ability to meet the specialist eligibility require-ments and the scientific importance of the research proposal,
- 7. Evidence of having obtained university degrees (officially certified copies of certificates and transcripts of records (e.g. for the Bachelor's, Master's, Diplom, Magister degrees) For OVGU degrees or Bachelor's degrees in combination with an OVGU Master's degree simple copies of all degrees are sufficient.)
- 8. Evidence of level of income in the form of a signed, tabular list with corresponding proofs (e.g. copy of the applicant's tax assessment notice, copy of contract of employ-ment, copies of wage slips or similar); the calendar year of the application is decisive (pursuant to GradFVO §4 para. 2 in conjunction with §7a para. 2).
- 9. In the case of applicants from abroad, the university degree granting access to the doc-toral program must be verified by K31.
- 10. In the case of Chinese, Vietnamese and Mongolian applicants, **in addition**, the records of academic achievement must be verified by the Academic Evaluation Center (APS) (see: <a href="https://www.aps.org.cn/zh/verfahren-und-services-deutschland/dokumentenprufverfahr;">https://www.aps.org.cn/zh/verfahren-und-services-deutschland/dokumentenprufverfahr;</a>

- 11. Where relevant, a copy of the applicant's Disabled Person's ID.

Post-graduate bursaries are generally awarded twice a year on **01.01**. and **01.07**. To ensure sufficient processing time, the applications for post-graduate funding together with all of the application documents must be submitted by

October 15th for funding commencing on January 1st,

**April 15th** for funding commencing on July 1st

to the dean's office in the relevant faculties. The application documents in points 1 - 7 must also be sent in parallel in a <u>single</u> PDF file to the Department of Academic Affairs, Student Secretariat for Doctoral Studies/Fees to the following email address: <u>christin.lobe@ovgu.de</u>

Please apply for admission to a doctoral program at OVGU Magdeburg <u>at the latest</u> during the month in which you apply for the post-graduate scholarship.
