General terms and conditions of the Otto-von-Guericke-University Magdeburg Center for Scientific Further Education (ZWW)

General Terms

- (1) These terms of participation apply to all short-term programmes offered by the Otto von Guericke University Magdeburg Center for Scientific Further Education (ZWW).
- (2) Short-term programmes include:
 - seminars
 - certificate courses
 - lectures
 - ring lectures
 - online courses

Registration and Conclusion of Contract

- (1) Registration for all continuing education programmes shall be made in writing (by either registration form, mail, fax or email to zww@ovgu.de). It must be submitted at the latest two weeks prior to commencement of the programme unless stated otherwise.
- (2) Upon receipt of your binding registration and examination of the admission requirements, you will receive written confirmation of your registration, concluding the contract. Registrations will be processed in order of receipt.

Right of Revocation

- (1) You have the right to withdraw from this contract within 14 days without stating your reasons for doing so. The withdrawal period is 14 days from the date of registration and ends no later than 14 days before the start of the programme. The withdrawal must be made in writing.

- (2) If you revoke this contract, we must reimburse you for all payments we have received from you immediately and no later than on the day of the start of the programme. On no account will you have to pay fees for this reimbursement.

Cancellation Policy

- (1) A resignation from or the cancellation of your participation in a registered programme must be made in writing.
- (2) In case you resign or cancel your participation in a chargeable programme, the following fees will have to be paid depending on the date of the cancellation:
 - 50 % of the participation fee in case of a cancellation 4 weeks prior to the commencement of the programme
 - 100 % of the participation fee in case of a cancellation 2 weeks prior to the commencement of the programme
- (3) A change in the person of the lecturer does not entitle the participant to resign from the programme.
- (4) Should you be able to name a substitute participant who fulfils the necessary requirements, he or she may participate instead and will receive a corresponding invoice.

Withdrawal and termination of programmes by the Center for Scientific Further Education (ZWW)

We reserve the right to cancel our programmes due to organizational reasons (e.g. in case the minimum number of participants has not been achieved or the lecturer is not available due to illness)

- (1) If that is the case, the registered participants will be informed immediately in writing or by e-mail about the cancellation of the programme.
- (2) The ZWW may decide whether it can offer you an alternative date or refund participation fees already paid. If an alternative date can be offered, you are nevertheless entitled to withdraw from the programme and demand a reimbursement of the fees; no further claims can be asserted.
- (3) Further liability and damage claims, except for damages or injuries to life, body and health, are excluded unless there is wilful intent or gross negligence on part of the ZWW.
- (4) Admission to the affiliated master's programme cannot be guaranteed. In case you are not admitted to the master's programme you are not entitled to any reimbursement or reduction of the participation fee of previously taken courses.

Fees

- (1) The participation fee for the respective programme is due at the scheduled starting date and will be invoiced. The final eligibility for participation is dependent on full payment of the participation fee. Access to online programmes is only granted after full payment of the fee.
- (2) If you fail to attend individual course dates or course hours or if the person of the lecturer has to be changed you are not entitled to a reduction of the participation fee.

Liability

- (1) The Otto-von-Guericke-University Magdeburg is not liable for damages suffered by the participant in the course of the programme unless these are based on intentional or grossly negligent behaviour of a vicarious agent.
